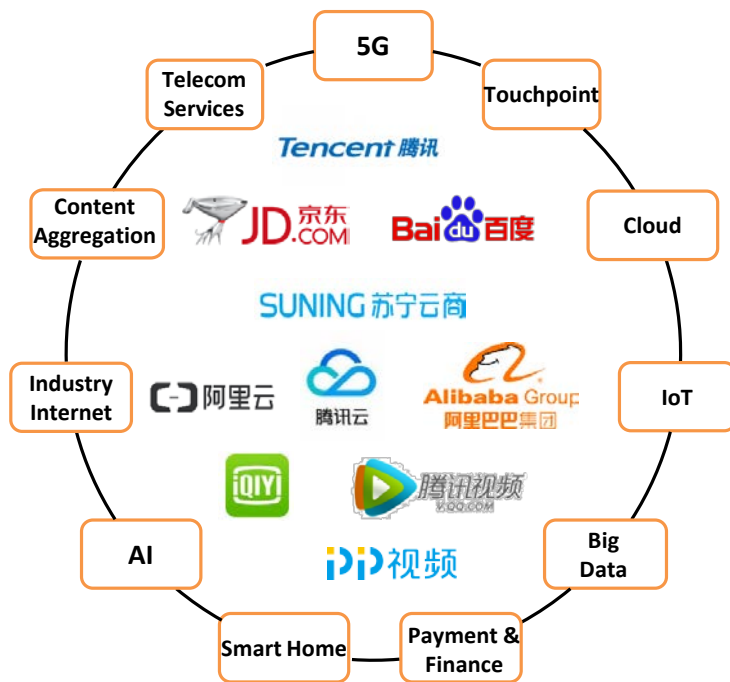
Fixed-line Service Revenue
